David S. G. Goodman is Professor of Contemporary China Studies at UTS. Recent publications include "China's Campaign to 'Open Up the West'", "China's Communist Revolutions", and "Social Change in Revolutionary China". He is currently writing a social history of the German colony of Qingdao. (*Mao and The Da Vinci Code: Conspiracy, Narrative and History*, pages 196-222.)

Vrasidas Karalis teaches Modern Greek at the University of Sydney. He is the editor of *Modern Greek Studies* (Australia and New Zealand). (*Patrick White and the Great Code of Hellenism*, pages 173-192.)

Mabel Lee is an Honorary Associate Professor in the School of Languages and Cultures at the University of Sydney. She is known internationally for her translations of 2000 Nobel Laureate Gao Xingjian's novels and short stories, and of 1999 winner of the Flaiano International Prize for Poetry: Yang Lian. Her most recent publication is Gao Xingjian's *The Case for Literature* (2006), a book of critical essays. Tony Lynch is a graduate of Sydney University and is currently Senior Lecturer in Philosophy and Politics at the University of New England. He is presently writing a book with his colleague Adrian Walsh on the moral philosophy of money. (*Iago's Evil*, pages 21-35.)

Duncan McIntyre studied Arts and Law at the University of Sydney, and practised law. He is married with three children. His interests include wine, poetry, history and science. Ruth Ronen is an Associate Professor of Philosophy at Tel Aviv University. Her publications include: *Possible Worlds in Literary Theory* (Cambridge 1994) and *Representing the Real* (Rodopi.2002). Last year she completed a book on the aesthetics of anxiety. She has published widely in aesthetics, narrative theory and on the relations between psychoanalytic thought and philosophy. Robert Sinnerbrink is a lecturer in philosophy at Macquarie University. He has published on critical theory, social philosophy, aesthetics and philosophy of cinema. 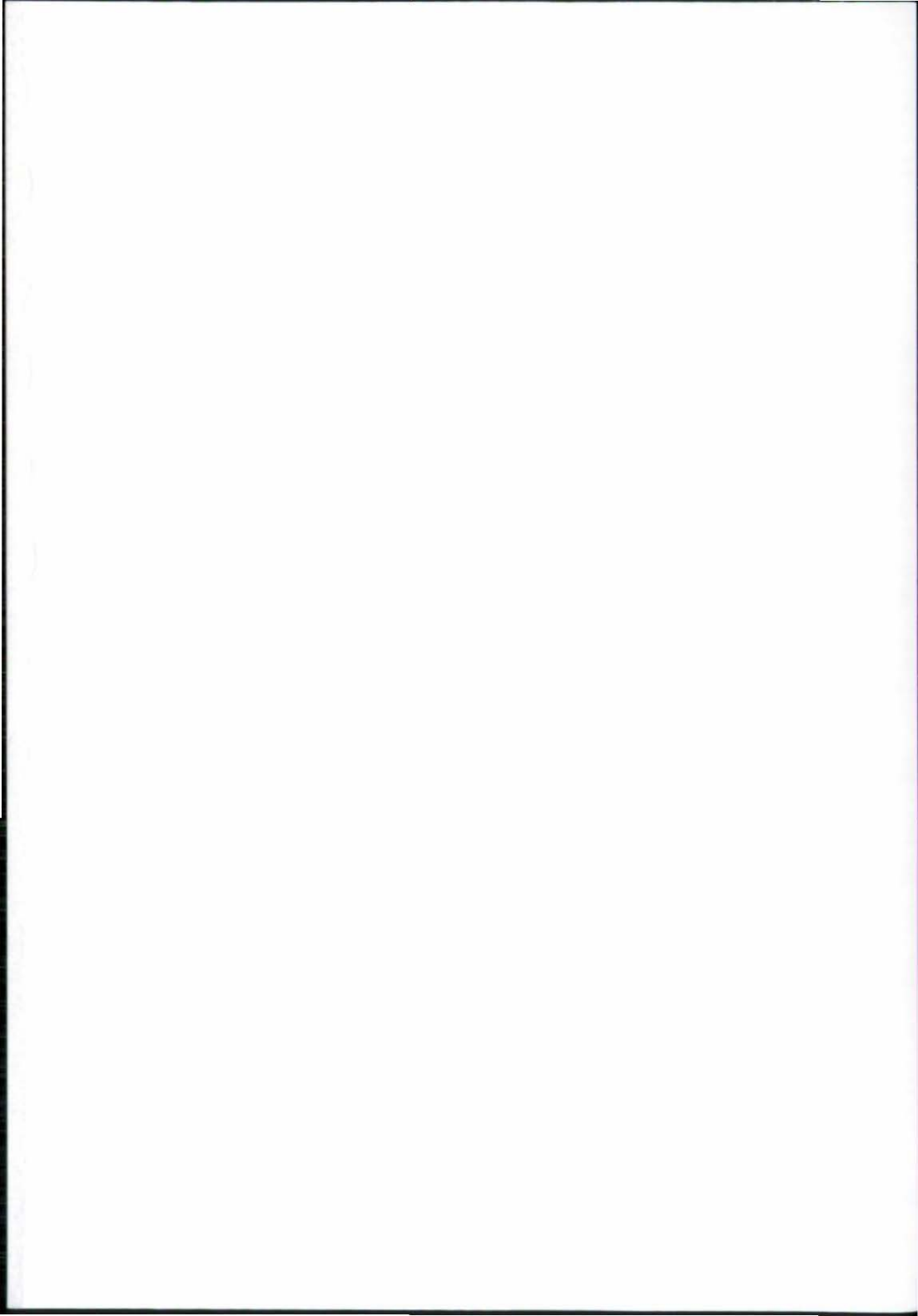
